



Scope

The Triple Helix of university-industry-government relations is an internationally recognized model for understanding entrepreneurship, the changing dynamics of universities, innovation and socio-economic development. The aim of the *Triple Helix (TH)* journal is to publish research for an international audience covering analysis, theory, measurements and empirical enquiry in all aspects of university-industry-government interactions. The objective is to unite key research on the transformations of universities, capitalization of knowledge, translational research, spin-off activities, intellectual property, knowledge and technology transfer, as well as the international bases and dimensions of Triple Helix relations, their impacts, social, economic, political, cultural, health and environmental implications as they arise from and shape Triple Helix interactions. Open to all innovation authors, the special mission of the journal is to be an international outlet also for innovation scholars from developing countries.

Open Access

Triple Helix is a fully Open Access journal, which means that all content will be freely accessible online. All articles will be published under a non-exclusive Open Access license. The article processing charge is €380. The author(s) keep full copyright and give Brill permission to publish by signing a special Brill Open Consent to Publish. Online Submission

Triple Helix uses online submission only. Authors should submit their manuscript online via the Editorial Manager (EM) online submission system at: editorialmanager.com/thj. First-time users of EM need to register first. Go to the website and click on the "Register Now" link in the login menu. Enter the information requested.



Instructions for Authors

When you register, select e-mail as your preferred method of contact. Upon successful registration, you will receive an e-mail message containing your Username and Password. If you should forget your Username and Password, click on the "Send Username/Password" link in the login section, and enter your first name, last name and email address exactly as you had entered it when you registered. Your access codes will then be e-mailed to you.

Prior to submission, authors are encouraged to read the 'Instructions for Authors.' When submitting via the website, you will be guided stepwise through the creation and uploading of the various files.

A revised document is uploaded the same way as the initial submission. The system automatically generates an electronic (PDF) proof, which is then used for reviewing purposes. All correspondence, including the editor's request for revision and final decision, is sent by e-mail.

Tables, illustrations and other figures should also be uploaded as separate source files.

Submission Requirements

Language

Manuscripts should be submitted in English. Spelling (American or UK) should be consistent throughout. Please note that the English language in the manuscripts should be of sufficient quality to be understood. If the author(s) is/are not native speakers and need help in writing, they should consider asking a native speaker to review their manuscripts or alternatively asking a professional language editing service.

Transliteration and Non-Roman Scripts

Authors should ensure that they use a Unicode friendly font such as the Brill (brill.com/about/brill-fonts). It presents complete coverage of the Latin script with the full range of diacritics and linguistics (IPA) characters used to display any language from any period; it includes, moreover, a complete set of the Greek polytonic characters, an extended Cyrillic set sufficient for the modern languages that use any kind of Cyrillic script, and a set of mathematical/logical symbols.

If you use any non-Roman font in your paper, please also include a pdf file of the manuscript.

Manuscript Structure

Manuscripts should be typed with a wide margin and double space between the lines. The first page should have ample space at the top around the title.

Title

Titles should be as short as possible. A (shortened) running title should be provided.

Abstract and Keywords

An abstract of 100–150 words and 2–6 keywords, in English, should be provided.

Headings

1 The First Level Heading

Italics

Italics should be used sparingly (but see below).

Latin quotations should be printed in italics.

References

The journal uses in text citation and a reference list.

For in text citations, please use the form: (Author and Author 2018); Author (2018) and Author (2016).

For three or more authors use the form Author et al. (2018). For more than one source from the same year it should be Author (2018a) and Author (2018b).

Reference List

The reference list should be in alphabetic order, with oldest material first.



Instructions for Authors

The titles of books and of journals (not of papers in journals) should be given in *italics*. For journal articles, please add the DOI number whenever available.

Proofs

At this stage in the production process only minor corrections are allowed. Alterations to the original manuscript at this stage will result in considerable delay in publication and, therefore, are not accepted unless charged to the author. Proof corrections should be returned promptly.
